Human life is considered as atop most priority of our organization & first point of our agenda on every activities planning.

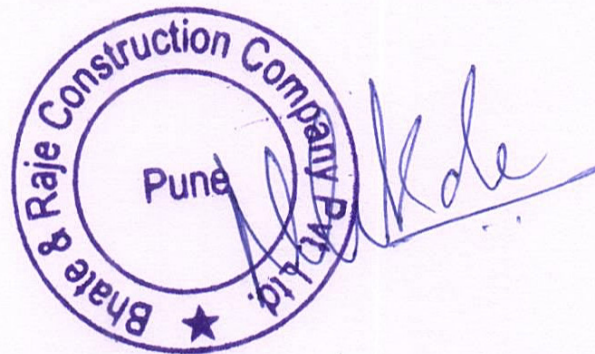
All activities carried out of construction site as considered as hazardous activity & every person is supposed to protect human from hazards & risk.

Sr.No	Activity / Process	PPE to be used
1	Entering the construction site	Personal ID card, Safety Helmet, safety Shoes, Earplug, Eye Goggle, Hand gloves, Dust Mask.
2	Excavation & Line Out	Safety Shoes, Helmet, Reflective Jacket, Earplug, Dust Mask, Hand Gloves, Ladder.
3	Reinforcement & Cement concreting Including scaffolding	Safety Shoes, Helmet, shoulder pad, Hand Gloves, Gum Boot, Goggle, Full Body Harness
4	Block / Brick Work	Safety Shoes, Helmet, Reflective Jacket, Dust Mask, Hand Gloves, Full Body Harness, Fall arrestor.
5	Working at Height & Edges	Full Body Harness, Helmet, Reflective Jacket, Safety Shoes.





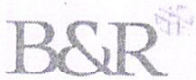
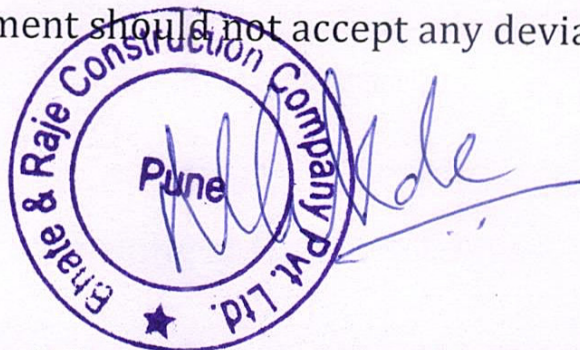

Sr No	Activity / Process	PPE to be used
6	Working with Tower Crane	Helmet, Reflective Jacket, Safety Shoes.
7	Flooring & Door Window	Helmet, Reflective Jacket, Safety Shoes, Goggle.
8	Painting & Fencing	Helmet, Reflective Jacket, Safety Shoes, Goggle, Dust Mask.
9	Façade Work	Helmet, Reflective Jacket, Safety Shoes, Goggle, Full Body Harness.
10	Development Work (Plumbing, Roads, Culverts, drainage)	Helmet, Reflective Jacket, Safety Shoes, Goggle, dusts Mask.
11	Electrical / Instrumentation (Use of DG, DB, Panel, Construction power supply)	Helmet, Reflective Jacket, Electric rated Shoes, Rubber Mat, and Electrical, Hand Gloves.
12	Welding & Gas Cutting	Leather apron, Leather Hand Gloves, Face Shield, Safety Shoes, Goggle.
